

TERMS AND CONDITIONS FOR THE DRAW OF TWO (2) PRIZES Tenerife Bluetrail by UTMB® 2027 – Val d'Arán Stand

ORGANISATION

PARTICIPATION PROCEDURE

- Fill in the requested information correctly: name, surname, email address, contact phone number, and nationality
- Accept these legal terms and the data protection policy.

WINNER SELECTION
